

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0592

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 29, 2015, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$6,385 overpayment, \$1,915.50 monetary penalty, and 49 penalty weeks (decision # 203518). On August 18, 2015, decision # 203518 became final without claimant having filed a timely request for hearing. On May 29, 2019, claimant filed a late request for hearing on decision # 203518. On June 4, 2019, ALJ Kangas issued Order No. 19-UI-131034, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire by June 18, 2019. Claimant did not file a timely response to the appellant questionnaire. On June 24, 2019, Order No. 19-UI-131034 became final without claimant having filed a questionnaire response or a timely application for review with the Employment Appeals Board (EAB). On June 26, 2019, claimant filed a late questionnaire response with the Office of Administrative Hearings (OAH) and a late application for review with EAB. On June 27, 2019, ALJ Kangas mailed a letter stating that claimant's late questionnaire would not be considered. This matter is before EAB on claimant's late application for review of Order No. 19-UI-131034.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On June 26, 2019, the appellant filed an application for review of Order No. 19-UI-131034 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than June 24, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the appellant provided a written statement (the appellant questionnaire) with his application for review, the written statement did not include any explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed June 26, 2019 is dismissed. Order No. 19-UI-131034 remains undisturbed.
