EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0595

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On February 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work during the weeks including December 30, 2018 through January 19, 2019 (weeks 01-19 through 03-19) and was ineligible for benefits for those weeks (decision # 122347). On February 25, 2019, decision # 122347 became final after no adversely affected party filed a timely request for hearing.

On May 7, 2019, the Department served notice of an administrative decision assessing a \$162 overpayment based on decision # 122347 (decision # 93339). On May 10, 2019, claimant filed a timely request for hearing on decision # 93339 and a late request for hearing on decision # 122347.

On May 17, 2019, ALJ Kangas issued Order No. 19-UI-130089, dismissing claimant's late request for hearing on decision # 122347 subject to claimant's right to renew the request by responding to an appellant questionnaire by May 31, 2019. On May 28, 2019, claimant submitted to the Office of Administrative Hearings (OAH) a timely response to the appellant questionnaire. On June 11, 2019, ALJ Kangas reviewed claimant's questionnaire response and issued Order No. 19-UI-131425, cancelling Order No. 19-UI-130089 and re-dismissing claimant's late request for hearing after concluding claimant failed to show good cause for the late request. Also on June 11, 2019, ALJ Janzen conducted a hearing on decision # 93339, and on June 12, 2019, issued Order No. 19-UI-131495, affirming decision # 93339. On June 28, 2019, claimant filed timely applications for review of Order Nos. 19-UI-131425 and 19-UI-131495 with the Employment Appeals Board (EAB).

With each of his applications for review, claimant submitted the same written argument. Claimant's written argument contained new information that was not part of the hearing record or relevant and material to the issues under review. Claimant's new information about being available for work during weeks 01-19 through 03-19 was not relevant because decision # 122347 was final and his appeal of that decision was dismissed because it was late. Accordingly, under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching these decisions.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 19-UI-131425 and 19-UI-131495. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0695 and 2019-EAB-0595, respectively).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), Order Nos. 19-UI-131425 and 19-UI-131495 are **adopted.**

DECISION: Order Nos. 19-UI-131425 and 19-UI-131495 are affirmed.
