

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0602

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from November 4, 2018 through November 10, 2018 (decision # 140615). Claimant filed a timely request for hearing. On January 24, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 6, 2019. On February 6, 2019, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 19-UI-124135, dismissing claimant's request for hearing due to his failure to appear. On February 26, 2019, Order No. 19-UI-124135 became final without claimant having filed a request to reopen the February 6, 2019 hearing. On May 16, 2019 claimant filed a late request to reopen the hearing. ALJ Kangas reviewed claimant's request, and on June 27, 2019 issued Order No. 19-UI-132393, denying his request. On July 1, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-132393 is affirmed.
