EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0611

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 26, 2019, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding that claimant willfully underreported earnings to obtain benefits, and therefore was overpaid \$590 in benefits, is disqualified for 8 weeks of future benefits, and assessed a \$88.50 monetary penalty (decision # 194821). On May 16, 2019, decision # 194821 became final without claimant having filed a request for hearing. On May 24, 2019, claimant filed a late request for hearing. On June 11, 2019, ALJ Kangas issued Order No. 19-UI-13199, dismissing claimant's request for hearing as late without a showing of good cause, subject to his right to renew his request by filing a response to an appellant questionnaire within 14 days. On June 26, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-13199 by the Employment Appeals Board (EAB). On June 27, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was late, she would not be considering the response or issue another order, and that Order No. 19-UI-13199 therefore remained in effect.

EAB has considered claimant's response to the appellant questionnaire when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The response has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: Claimant personally received decision # 194821 on or about May 14, 2019, two days before the decision became final. Claimant had been working out-of-town since the first week of April 2019 and did not check his mail until he returned on May 14th. Claimant filed a request for hearing on May 24, 2019, ten days after he returned.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant personally received decision # 194821 on or about May 14, 2019, two days before the decision became final, and did not file his request for hearing until May 24, 2019, approximately 10 days later. Claimant did not explain why he failed to file a request for hearing until 10 days after he received the decision. Absent such an explanation, claimant failed to establish good cause to extend the filing deadline to May 24, 2019. Claimant's late request for hearing on decision # 194821 therefore is dismissed.

DECISION: Order No. 19-UI-131399 is affirmed.
