

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0621

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On April 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 85005). Claimant filed a timely request for hearing. On May 23, 2019 and June 6, 2019, ALJ Shoemake conducted a hearing, and on June 14, 2019 issued Order No. 19-UI-131719, concluding the employer discharged claimant for misconduct. On July 5, 2019, Order No. 19-UI-131719 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 6, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

The filing date of an application for review filed by mail is the postmark date affixed to the envelope. OAR 471-041-0065(1)(b). The postmark date on the envelope in which claimant mailed the application for review was July 6, 2019. Therefore, July 6, 2019 was the date claimant filed the application for review of Order No. 19-UI-131719 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than July 5, 2019, however, so claimant's application for review was filed late. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Claimant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed July 6, 2019 is dismissed. Order No. 19-UI-131719 remains undisturbed.
