EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0624

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 11, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was unavailable for work from March 3 through 30, 2019 (decision # 153438). Claimant filed a timely request for hearing. On May 6, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 20, 2019. On May 20, 2019, claimant failed to appear at the hearing, and ALJ Seideman issued Order No. 19-UI-130224, dismissing claimant's request for hearing for failure to appear. Claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on June 14, 2019 issued Order No. 19-UI-131679, denying the request. On July 5, 2019, Order No. 19-UI-131679 became final without claimant having filed an application for review by the Employment Appeals Board (EAB). On July 6, 2019 at 12:04 a.m., claimant filed, by fax to OAH, a late application for review by EAB.¹

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 19-UI-131679 is dismissed.

An application for review may be filed in person, or by mail, fax, or electronic means to EAB, or any office of the Employment Department, including OAH, or any Employment Security Agency in any other state or jurisdiction where the applicant is claiming benefits. OAR 471-041-0060(2) (May 13, 2019). If faxed, the filing date is the encoded date on the faxed document. *See* OAR 471-041-0060(1)(d) (May 13, 2019).

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable

control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

Here, claimant's application for review states that it was filed on July 5, 2019. However, the encoded date on the application for review faxed to OAH is July 6, 2019. Thus, under OAR 471-041-0060(1)(d), the application for review was filed on July 6th, after the July 5th filing deadline. The application for review does not included a written statement describing the circumstances that prevented a timely filing, as required under OAR 471-041-0070(3). The application for review therefore is dismissed.

DECISION: The application for review filed July 6, 2019 is dismissed. Order No. 19-UI-131679 remains undisturbed.
