PROCEDURAL HISTORY AND FINDINGS OF FACT: On August 2, 2017, claimant filed an initial claim for benefits, and filed weekly claims for benefits until February 5, 2018. On April 4, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause on November 14, 2017, and was overpaid \$6,456 in benefits that he must repay the Department (decision # 90820). On April 24, 2018, decision # 90820 became final without claimant having filed a request for hearing.

On June 7, 2018, claimant filed a late request for hearing. On June 18, 2018, ALJ Kangas issued Order No. 18-UI-111519, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew his request by filing a response to an appellant questionnaire by July 2, 2018. Claimant never received Order No. 18-UI-111519, which therefore became final on July 9, 2018 without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB).

On May 9, 2019, claimant filed an initial claim for benefits, and on May 13, 2019 began filing weekly claims for benefits. On June 12, 2019, claimant became aware that he was not being paid benefits due to an overpayment, and contacted the Department. Claimant first became aware of Order No. 18-UI-111519 on June 12, 2019 and filed a late application for review with EAB the same day.

On June 24, 2019, EAB issued Appeals Board Decision 2019-EAB-0549, allowing claimant's late application for review, and remanding the case to the Office of Administrative Hearings (OAH) for a hearing on claimant's late request for hearing. On July 2, 2019, ALJ Janzen conducted a hearing, and on July 8, 2019 issued Order No. 19-UI-132895, allowing claimant's late request for hearing, and affirming decision # 90820. On July 9, 2019, claimant filed a timely application for review of Order No. 19-UI-132895 with EAB.

EAB reviewed the entire hearing record and claimant's argument. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-132895 is affirmed.
