EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0628

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 6, 2018, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 111440). On November 26, 2018, decision # 111440 became final without claimant having filed a request for hearing. On June 6, 2019, claimant filed a late request for hearing. On June 12, 2019, ALJ Kangas issued Order No. 19-UI-131529, dismissing claimant's request for hearing as late without a showing of good cause, subject to his right to renew his request by filing a response to an appellant questionnaire by June 26, 2019. On July 1, 2019, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 19-UI-131529 by the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence has been marked as EAB Exhibits 1 and 2, and copies provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 111440 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In his response to the appellant the appellant questionnaire attached to Order No. 19-UI-131529, claimant asserted that he filed his request for hearing on decision # 111440 over six months late because he never received the decision in the mail. EAB Exhibit 1. However, there is a presumption that a letter duly directed and mailed was received in the regular course of the mail. ORS 40.135(1)(q). Claimant's bare assertion of non-receipt fails to overcome that presumption. Moreover, even if claimant did not receive decision # 111440 in the mail, he did not state when he otherwise became aware of the decision in his request for hearing or response to the appellant questionnaire. *See* Exhibit 2; EAB Exhibit 1. Department records indicate that claimant filed a weekly claim for benefits on November 13, 2018 that was denied based on decision # 111440, suggesting that he may have become aware of the decision shortly thereafter. Absent a showing that he was unaware of the decision until after November 26, 2018, and that he filed his request for hearing within seven days after becoming aware of the decision, claimant failed to establish good cause to extend the filing deadline to June 6, 2019.

Claimant's late request for hearing on decision # 111440 therefore is dismissed.

DECISION: Order No. 19-UI-131529 is affirmed.
