

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0631**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On April 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work from March 3, 2019 through March 9, 2019 (decision # 94332). On April 9, 2019, the Department served two notices of two administrative decisions, one concluding that claimant was not available for work from March 3, 2019 through April 6, 2019 and until the circumstances causing her unavailability ceased (decision # 75032), and the other concluding that claimant was not entitled to benefits in her claim based upon wages between October 1, 2017 and September 30, 2018 because she was not authorized to work in the U. S. during that base year (decision # 75725).

On April 24, 2019, decision # 94332 became final without claimant having filed a timely request for hearing. On April 29, 2019, decisions # 75032 and 75725 became final without claimant having filed a timely request for hearing.

On May 15, 2019, claimant filed late requests for hearing on decisions # 75032, 75725, and 94332. On May 28, 2019, ALJ Kangas issued Order Nos. 19-UI-130613, dismissing claimant's late request for hearing on decision # 94332, 19-UI-130615, dismissing claimant's late request for hearing on decision # 75725, and 19-UI-130648, dismissing claimant's request for hearing on decision # 75032. All three Orders were issued subject to claimant's right to renew the request by responding to an appellant questionnaire by June 11, 2019.

Claimant filed a timely response to the appellant questionnaires. On July 1, 2019, ALJ Kangas reviewed claimant's responses and issued Order No. 19-UI-132604, re-dismissing claimant's late request for hearing on decision # 75725, Order No. 19-UI-132605, re-dismissing claimant's late request for hearing on decision # 94332, and Order No. 19-UI-132606, re-dismissing claimant's late request for hearing on decision # 75032.

On July 8, 2019, claimant filed timely applications for review of Order Nos. 19-UI-132604, 19-UI-132605, and 19-UI-132606 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Order Nos. 19-UI-132604, 19-UI-132605, and 19-

UI-132606. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2019-EAB-0629, 2019-EAB-0630, and 2019-EAB-0631).

EAB reviewed the entire hearing record in each of the three consolidated cases. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order Nos. 19-UI-132604, 19-UI-132605, and 19-UI-132606 are affirmed.
