

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0636

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On May 14, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from April 21, 2019 to April 27, 2019 and until the reason for the denial had ended (decision # 133511). Claimant filed a timely request for hearing. On May 29, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for June 10, 2019 at 9:30 a.m., at which claimant failed to appear. On June 11, 2019, ALJ Meerdink issued Order No. 19-UI-131430, dismissing claimant's hearing request for failure to appear. On June 17, 2019, claimant filed a request to reopen the June 10th 9:30 a.m. hearing. On June 25, 2019, ALJ Kangas reviewed the request and issued Order No. 19-UI-132268, denying claimant's reopen request. On July 10, 2019, claimant filed a timely application for review of Order No. 19-UI-132268 with the Employment Appeals Board (EAB).

EAB considered claimant's written argument when reaching this decision. Although due to the procedural posture of this case claimant is not entitled to present evidence to EAB about the merits of decision # 133511 as claimant requested, that decision states that it only denies benefits on a week-by-week basis. That means that if claimant has information suggesting that the circumstances that caused the Department to issue that decision have changed, claimant may directly contact the Department and provide a description of claimant's current availability so the Department can determine if the reason for the denial has now ended.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-132268 is affirmed.
