EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0647

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On April 26, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$356.00 overpayment that claimant was liable to repay (decision # 194823). Claimant filed a timely request for hearing. On May 28, 2019, ALJ Wyatt conducted a hearing, and on May 31, 2019, issued Order No. 19-UI-130907, affirming the Department's decision. On June 20, 2019, Order No. 19-UI-130907 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 9, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

The filing date of an application for review mailed to EAB is the postmark date affixed to the envelope in which it was mailed. OAR 471-041-0065(1)(b). If the postmark date is missing, then the filing date is the date that EAB determines to be the most probable date of filing. OAR 471-041-0065(2).

In this case, claimant filed the application for review by mail, but the envelope did not include a postmark to establish the filing date. EAB must therefore determine the most probable date of filing. EAB received the envelope on July 12, 2019. The U. S. Postal Service customarily delivers first class mail within one to three business days.¹ Three days prior to July 12, 2019 was July 9, 2019, making July 9, 2019 the most probable date of filing.² ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than June 20, 2019. Claimant's application for review therefore was filed approximately 19 days late.

¹ EAB has taken notice of this fact, which is a generally cognizable fact. OAR 471-041-0090(1) (May 13, 2019). A copy of the information is available to the parties at <u>https://www.usps.com/ship/mail-shipping-services.htm</u>. Any party that objects to our taking notice of this information must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the noticed fact will remain in the record.

² Whether claimant's application for review took three days for the U. S. Postal Service to deliver is unknowable; in concluding that the most probable date of filing was three days prior to delivery we have assumed facts in the light most favorable to claimant's position.

The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.³

DECISION: The application for review filed July 9, 2019 is dismissed. Order No. 19-UI-130907 remains undisturbed.

³ In reaching this decision, we considered the fact that claimant did not sign and date the application for review form submitted in this case until July 4, 2019, which was already five days past the filing deadline. Therefore, although we cannot conclusively state exactly what the filing date was in this case, the record is conclusive that claimant did not place the application for review in the mail until well after the filing deadline expired.
