

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0657

Affirmed
Late Request for Hearing Dismissed
Overpayment Assessed

PROCEDURAL HISTORY: On March 5, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from January 20, 2019 through February 9, 2019 (decision # 143030). On March 25, 2019, decision # 143030 became final without claimant having filed a timely request for hearing.

On June 7, 2019, the Department issued notice of another administrative decision, based upon decision # 143030, concluding the Department overpaid claimant \$501.00 in unemployment insurance benefits that he was liable to repay (decision # 125527). On June 7, 2019, claimant filed a late request for hearing on decision # 143030 and a timely request for hearing on decision # 125527.

On June 24, 2019, ALJ Snyder conducted two hearings, and on July 2, 2019, issued Order No. 19-UI-132675, dismissing claimant's late request for hearing on decision # 143030, and Order No. 19-UI-132680, affirming decision # 125527. On July 13, 2019, claimant filed timely applications for review of both orders with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 19-UI-132675 and 19-UI-132680. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0657 and 2019-EAB-0658).

EAB reviewed the entire hearing record in both cases. On de novo review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 19-UI-132675 and Order No. 19-UI-132680 are affirmed.
