## **EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0660**

*Order No. 19-UI-132456 Affirmed  
Disqualification*

*Order No. 19-UI-132455 Affirmed  
Ineligible Weeks 20-19 through 24-19*

**PROCEDURAL HISTORY:** On May 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision-concluding claimant voluntarily left work without good cause (decision # 74425). On May 22, 2019, the Department served notice of a separate administrative decision concluding claimant did not provide information requested by the Department to process her claim, and was not eligible to receive benefits from May 12, 2019 through May 18, 2019 (decision # 93939). Claimant filed timely requests for hearing on both decisions. On June 20, 2019, ALJ Snyder conducted separate hearings, and on June 27, 2019, issued Order No. 19-UI-132456 affirming decision # 74425, and Order No. 19-UI-132455 modifying<sup>1</sup> decision # 93939 and concluding claimant was not eligible to receive benefits from May 12, 2019 through June 15, 2019. On July 16, 2019, claimant filed an application for review of each order with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095, EAB consolidated its review of Order Nos. 19-UI-132456 and 19-UI-132455. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0659 and 2019-EAB-0660, respectively).

In support of her application for review, claimant submitted a written argument. Claimant did not declare that she provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

<sup>1</sup> Order No. 19-UI-132455 incorrectly states that it is affirming decision # 93939.

EAB reviewed both hearing records in their entirety. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Order Nos. 19-UI-132456 and 19-UI-132455 are affirmed.
