

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0666**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On May 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not provide the Department with information necessary to process the claim, and denying benefits from May 5, 2019 through May 11, 2019 and until claimant provided the information as required. On June 4, 2019, that decision became final without claimant having filed a timely request for hearing. On June 5, 2019, claimant filed a late request for hearing.<sup>1</sup> On June 11, 2019, ALJ Kangas reviewed claimant's request and issued Order No. 19-UI-131373, dismissing the request, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 25, 2019. Claimant did not respond to the appellant questionnaire. On July 1, 2019, claimant filed a timely application for review of Order No. 19-UI-131373 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-131373 is affirmed.
