

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0671

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On May 23, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily quit work without good cause (decision # 134935). Claimant filed a timely request for hearing. On June 24, 2019, ALJ Logan conducted a hearing, and on June 26, 2019, issued Order No. 19-UI-132291, concluding claimant voluntarily quit work without good cause. On July 16, 2019, Order No. 19-UI-132291 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 22, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On July 22, 2019, the appellant filed an application for review of Order No. 19-UI-132291 with the Employment Appeals Board (EAB). ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than July 16, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed July 22, 2019 is dismissed. Order No. 19-UI-132291 remains undisturbed.
