

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0679

Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On November 8, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 112035) and an administrative decision concluding claimant was not available for work from October 21, 2018 through October 27, 2018 (decision # 114645). On November 28, 2018, decisions # 112035 and # 114645 became final without claimant having filed timely requests for hearing. On June 21, 2018, claimant filed late requests for hearing on decisions # 112035 and # 114645. On June 27, 2019, ALJ Kangas issued Orders No. 19-UI-132382 and No. 19-UI-132385, dismissing claimant's requests for hearing on decisions # 112035 and # 114645 as untimely without a showing of good cause subject to his right to renew the requests by responding to appellant questionnaires by July 11, 2019. On July 7, 2019, claimant filed timely responses to the appellant questionnaires. ALJ Kangas reviewed claimant's responses, and on July 17, 2019 issued Orders No. 19-UI-133540 and 19-UI-133542 re-dismissing claimant's requests for hearing on decisions # 112035 and # 114645 as untimely without good cause. On July 19, 2019, claimant filed applications for review of Orders No. 19-UI-133540 and 19-UI-133542 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Order No. 19-UI-133540 and Order No. 19-UI-133542. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0679 and 2019-EAB-0680).

On *de novo* review of the entire hearing records and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Orders No. 19-UI-133540 and 19-UI-133542 are affirmed.
