

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0682

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On April 18, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 75712). Claimant filed a timely request for hearing. On April 30, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for May 13, 2019, at which time claimant failed to appear. On May 13, 2019, ALJ S. Lee issued Order No. 19-UI-129766, dismissing claimant's request for hearing for failure to appear. On May 13, 2019, claimant filed a timely request to reopen the hearing. On May 15, 2019, OAH mailed notice of a hearing on claimant's reopen request scheduled for May 29, 2019, at which time claimant again failed to appear. On May 29, 2019, ALJ S. Lee issued Order No. 19-UI-130714, dismissing claimant's request for failure to appear. On June 18, 2019, Order No. 19-UI-130714 became final without claimant having filed a timely request to reopen. On approximately June 21, 2019, claimant filed a late request to reopen the May 29th hearing.¹ ALJ Kangas reviewed claimant's request to reopen, and on July 2, 2019 issued Order No. 19-UI-132686, denying claimant's request. On July 20, 2019, claimant filed a timely application for review of Order No. 19-UI-132686 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-132686 is affirmed.

¹ Claimant mailed her request to reopen to OAH. The filing date of documents filed by mail is the postmarked date or, if the postmark is absent, the most probable date of mailing. OAR 471-040-0005(4)(b). The envelope in which claimant mailed her request did not have a postmark. However, it was received on June 24, 2019. Documents sent through the U.S. Postal Service are typically delivered 1-3 days after mailing. <https://www.usps.com/ship/mail-shipping-services.htm>. Assuming facts most favorable to claimant, the most probable date of mailing would be therefore be three days before it was received, or June 21, 2019. The filing date for claimant's request to reopen was therefore June 21, 2019.
