

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0707

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On May 31, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and that her benefit rights based on wages earned prior to May 7, 2019 were canceled (decision # 145804). Claimant filed a timely request for hearing. On June 20, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for June 28, 2019, at which claimant failed to appear. On July 1, 2019, ALJ Monroe issued Order No. 19-UI-132566, dismissing claimant's request for hearing for failure to appear. On July 9, 2019, claimant filed an application for review that was construed as a request to reopen under OAR 471-041-0060(4). ALJ Kangas considered the request to reopen, and on July 22, 2019 issued Order No. 19-UI-133757, denying the request. On July 26, 2019, claimant filed an application for review of Order No. 19-UI-133757 with the Employment Appeals Board (EAB).

Claimant submitted a written argument that contained information about her reasons for missing the June 28th hearing that suggested she might have had good cause to reopen the hearing. However, the information she provided to EAB was not part of the hearing record. Before EAB can consider information that is not part of the hearing record, claimant has to show that factors or circumstances beyond her reasonable control prevented her from providing the information along with her request to reopen, as required under OAR 471-040-0040. *See* ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019). Claimant did not provide any explanation for why she did not submit the information with her reopen request. Therefore, EAB could not consider claimant's information, and considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-133757 is affirmed.
