

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0711-R

Affirmed on Reconsideration
Requests to Reopen Denied

PROCEDURAL HISTORY: On May 24, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for ANR Group without good cause (decision # 141612), and an administrative decision concluding that claimant quit working for First Call Resolution LLC without good cause (decision # 135343). Claimant filed timely requests for hearing on both decisions. On June 18, 2019, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 141612 scheduled for July 1, 2019 at 8:15 a.m., and a hearing on decision # 135343 scheduled for July 1st at 9:30 a.m. On July 1st, claimant failed to appear at both hearings, and ALJ Seideman issued Orders No. 19-UI-132578 and 19-UI-132577, dismissing claimant's requests for hearing for failure to appear. Claimant filed timely requests to reopen the hearings. ALJ Kangas reviewed claimant's requests to reopen, and on July 16, 2019 issued Orders No. 19-UI-133428 and 19-UI-133430, denying the requests.

On July 29, 2019, claimant filed timely applications for review of Orders No. 19-UI-133428 and 19-UI-133430 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-133428 and 19-UI-133430. On August 9, 2019, EAB issued duplicate decisions, EAB Decisions 2019-EAB-0711 and 2019-EAB-0712, affirming Orders No. 19-UI-133428 and 19-UI-133430.

On August 12, 2019, after EAB issued EAB Decisions 2019-EAB-0711 and 2019-EAB-0712, EAB processed documents sent by claimant that had been received on August 7, 2019. The documents consisted of timely written arguments that claimant was entitled to have considered before EAB issued decisions in these matters. EAB therefore reopened these cases on its own motion pursuant to ORS 657.290(3) to reconsider their outcomes.

EAB has reviewed the entirety of both hearing records under review, including the content of claimant's documents received on August 7, 2019. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **re-adopted**.

DECISION: Orders No. 19-UI-133428 and 19-UI-133430 are affirmed.
