

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0714**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On May 28, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1,020.00 overpayment, \$204.00 monetary penalty, and seven penalty weeks (decision # 194118). On June 17, 2019, decision # 194118 became final without claimant having filed a timely request for hearing. On June 27, 2019, claimant filed a late request for hearing. On July 1, 2019, ALJ Kangas issued Order No. 19-UI-132572, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire by July 15, 2019. On July 18, 2019, claimant submitted a late response to the appellant questionnaire and a timely application for review with the Employment Appeals Board (EAB). On July 29, 2019, ALJ Kangas mailed a letter to claimant stating that his late questionnaire response would not be considered. This matter is before EAB based upon claimant's July 18<sup>th</sup> timely application for review.

EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's late response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDINGS OF FACT:** Claimant received decision # 194118. He misread the paperwork and thought he had 60 days to request a hearing. Nothing prevented claimant from filing his request for hearing sooner had he realized he did not have 60 days to file it.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing should be dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

Claimant did not show good cause to file the late request for hearing. It was within claimant’s reasonable control to read the administrative decision, including the deadline for requesting a hearing. Although claimant’s misunderstanding about the filing deadline was likely the result of a mistake on his part, it was not an “excusable mistake” within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply.

Claimant also did not show that he filed his late request for hearing within a “reasonable time.” To file within a “reasonable time” claimant must have filed the late request for hearing within seven days of realizing that he needed to file one or had missed the deadline. Claimant did not explain what date he realized he did not have 60 days to file his request for hearing. The record therefore does not show that claimant’s June 27<sup>th</sup> filing occurred within seven days of that date.

Claimant did not establish good cause or that he filed within a reasonable time. His late request for hearing must therefore be dismissed.

**DECISION:** Order No. 19-UI-132572 is affirmed.
