EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0717

Affirmed Ineligible Weeks 21-19 Through 29-19

PROCEDURAL HISTORY: On July 2, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from May 19, 2019 through June 29, 2019 and until the reason for claimant's denial ended (decision # 145830). Claimant filed a timely request for hearing. On July 24, 2019, ALJ S. Lee conducted a hearing, and on July 31, 2019, issued Order No. 19-UI-134292, concluding claimant was not available for work from May 19, 2019 through July 20, 2019. On August 3, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted written argument to EAB. Claimant asserted that they did not decline any work due to school, "promptly gained employment," and was denied benefits based on "not being available for a hypothetical position." Claimant's Written Argument. Claimant was available to work in a position that did not conflict with their school schedule. However, to have been eligible for benefits from May 19 through July 20, 2019, claimant had to show that they were available for work during all the days and hours customary for the work they sought, which included work that was customarily performed during all shifts, on all days, in claimant's labor market. See OAR 471-030-0036(3)(a) (April 1, 2018). Claimant's class schedule was four days per week, for blocks of time up to eight hours long. Although claimant found work that did not substantially conflict with their school schedule, during the weeks at issue, there was the possibility that claimant might have found work that conflicted with their school schedule, and claimant was not willing to accept that work. Therefore, claimant's school attendance limited the scope of jobs claimant was available to accept. In other words, because claimant was attending school during hours that conflicted with the work they sought, claimant was not available for all potential work of the type sought in claimant's labor market. Claimant was therefore not available for work under Employment Department law during the weeks at issue.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-134292 is affirmed.
