

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0719**

*Applications for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On March 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from February 10, 2019 through February 23, 2019 (decision # 84324). On March 26, 2019, decision # 84324 became final without claimant having filed a timely request for hearing. On May 31, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$582 overpayment that claimant was liable to repay (decision # 140724). On June 17, 2019, claimant filed a late request for hearing on decision # 84324 and a timely request for hearing on decision #140724. On July 5, 2019, ALJ Scott conducted a hearing, and on July 10, 2019 issued Order No. 19-UI-133086, dismissing claimant's late request for hearing on decision # 84324. On July 11, 2019, ALJ Scott issued Order No. 19-UI-133146, affirming decision # 140724. On July 30, 2019, Order No. 19-UI-133086 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 31, 2019, Order No. 19-UI-133146 became final without claimant having filed an application for review with the EAB. On August 1, 2019, claimant filed late applications for review of Order No. 19-UI-133086 and Order No. 19-UI-133146 with EAB.

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-133086 and 19-UI-133146. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0718 and 2019-EAB-0719).

**CONCLUSIONS AND REASONS:** The applications for review should be dismissed.

On August 1, 2019, the appellant filed applications for review of Order No. 19-UI-133086 and Order No. 19-UI-133146 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than July 30, 2019 and July 31, 2019, respectively. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the appellant included a written statement with the applications for review, the written statement did not

include any explanation as to why the applications were filed after the filing deadlines expired. Accordingly, the applications for review are dismissed.

**DECISION:** The applications for review filed August 1, 2019 are dismissed. Orders No. 19-UI-133086 and 19-UI-133146 remain undisturbed.
