

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0739**

*Affirmed*  
*Disqualified*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On May 15, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, not for misconduct (decision # 144129). The employer filed a timely request for hearing. On June 5, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for June 14, 2019 to the parties at their addresses of record. On June 14, 2019, ALJ Murray-Roberts conducted a hearing at which claimant failed to appear, and on June 20, 2019 issued Order No. 19-UI-131981, concluding claimant voluntarily quit working for the employer without good cause. Claimant filed a timely request to reopen the June 14, 2019 hearing. On July 17, 2019, ALJ Murray-Roberts conducted a hearing on claimant's request for a reopening and on July 18, 2019 issued Order No. 19-UI-133578, denying the request. On August 7, 2019, claimant filed applications for review of Orders Order No. 19-UI-131981 and No. 19-UI-133578 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Order No. 19-UI-131981 and Order No. 19-UI-133578. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0739 and 2019-EAB-0742).

Claimant submitted written argument with his applications for review. However, claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information into the hearing record in his request to reopen the June 14, 2019 hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

On *de novo* review of the entire hearing records and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

**DECISION:** Order No. 19-UI-131981 and Order No. 19-UI-133578 are affirmed.
