PROCEDURAL HISTORY: On March 16, 2019, the Oregon Employment Department (the Department) served notice, by mail, of an administrative decision concluding claimant was not actively seeking work from February 3, 2019 through February 16, 2019, and was not eligible to receive unemployment benefits for that time period (decision # 81339). On April 18, 2019, decision # 81339 became final without claimant having filed a request for hearing. On June 28, 2019, the Department served notice of another decision concluding that claimant was overpaid \$1,228 based on decision # 81339 (decision # 131048). On July 5, 2019, claimant filed a late request for hearing on decision # 81339 and a timely request for hearing on decision # 131048. On July 12, 2019, ALJ M. Davis conducted combined hearings, and on July 25, 2019 issued Order No. 19-UI-134013, denying claimant's late request for hearing on decision # 81339, and Order No. 19-UI-134015, affirming decision # 131048.

On August 9, 2019, claimant filed a timely application for review of Orders No. 19-UI-134013 and 19-UI-134015 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Order No. 19-UI-134013 and Order No. 19-UI-134015. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0755 and 2019-EAB-0756).

On *de novo* review of the entire hearing records and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Order No. 19-UI-134015 and Order No. 19-UI-134013 are affirmed.
