

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0761

PROCEDURAL HISTORY: On October 24, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 104349). Claimant filed a timely request for hearing. On December 4, 2018, January 3, 1029, January 23, 2019, February 28, 2019, March 27, 2019, and April 24, 2019, ALJ Wyatt conducted a hearing, and on May 1, 2019 issued Order No. 19-UI-129161, concluding claimant was an employee and was discharged, not for misconduct. On May 9, 2019, the employer filed an application for review with the Employment Appeals Board (EAB). On June 4, 2019, EAB issued Employment Appeal Board Decision 2019-EAB-0454, reversing and remanding the case to the Office of Administrative Hearings (OAH) to complete the record. On July 31, 2019, ALJ Wyatt issued Order No. 19-UI-134285, clarifying the record and again concluding claimant was an employee and was discharged, not for misconduct. On August 9, 2019, the employer filed an application for review with EAB. The employer also requested that EAB issue a subpoena for additional evidence. On August 21, 2019, EAB denied the employer's request by letter.

EAB reviewed the entire hearing record, including the employer's written arguments. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.
