# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0783

Reversed
Late Request for Hearing Allowed
Merits Hearing Required

PROCEDURAL HISTORY: On June 28, 2019, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 145843). On July 18, 2019, decision # 145843 became final without claimant having filed a request for hearing. On July 20, 2019, claimant filed a late request for hearing. On July 24, 2019, ALJ Kangas issued Order No. 19-UI-133859, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 7, 2019. On August 13, 2019, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 19-UI-133859 with the Employment Appeals Board (EAB). On August 15, 2019, ALJ Kangas issued a letter stating that because claimant's response was late, it would not be considered, another order would not be issued, and Order No. 19-UI-133859 remained in effect.

EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) The Department mailed decision # 145843 to claimant's mailing address in Woodburn, Oregon. At that time, however, claimant was living and working in Salem, Oregon, but was homeless and could not afford to travel to Woodburn to check his mail very often.

(2) Claimant filed a late request for hearing on decision # 145843 because he did not check his mail from the time the decision was delivered to his mailing address until it was too late to comply with the July 18<sup>th</sup> filing deadline. Claimant filed his late request for hearing two days after the filing deadline.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing on decision # 145843 is allowed. Claimant is entitled to a hearing on the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant filed a late request for hearing on decision # 145843 because he did not check his mail from the time the decision was delivered to his mailing address in Woodburn until after the July 18<sup>th</sup> filing deadline. However, claimant failed to check his mail during that time period due to factors beyond his reasonable control – he was living and working in Salem, but was homeless and could not afford to travel to Woodburn to check his mail very often. Claimant therefore established good cause for filing his request for hearing late. And because claimant filed his request for hearing only two days after the filing deadline, he filed it within a reasonable time.

Claimant's late request for hearing on decision # 145843 therefore is allowed. Claimant is entitled to a hearing on the merits of that decision.

**DECISION:** Order No. 19-UI-133859 is set aside, as outlined above.
