

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0811**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On May 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause (decision # 172027) and another decision based in part on decision # 172027, concluding that claimant was overpaid \$5,325 in benefits that he must repay the Department, was disqualified from 35 weeks of future benefits, and assessed a \$798.75 monetary penalty (decision # 194329). On May 29, 2019, decisions # 172027 and # 194329 became final without claimant having filed a request for hearing. On July 17, 2019, claimant filed a late request for hearing on decisions # 172027 and # 194329. On July 22, 2019, ALJ Kangas issued Orders No. 19-UI-133725 and 19-UI-133726, dismissing claimant's late requests for hearing as late without a showing of good cause, subject to his right to renew the requests by responding to appellant questionnaires by August 5, 2019. Claimant filed timely responses to the appellant questionnaires. ALJ Kangas reviewed claimant's response, and on August 15, 2019 issued Orders No. 19-UI-135111 and 19-UI-135114 re-dismissing claimant's requests for hearing on decisions # 172027 and # 194329 as untimely without good cause.

On August 18, 2019, claimant filed a timely application for review of Orders No. 19-UI-135111 and 19-UI-135114 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019); EAB consolidated its review of Orders No. Orders No. 19-UI-135111 and 19-UI-135114. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0811 and 2019-EAB-0812).

Claimant submitted written argument with their application for review. However, claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained additional evidence. Under OAR 471-041-0090(1)(b) and ORS 657.275(2) (May 13, 2019) EAB may only consider a party's additional evidence if the information is relevant and material to EAB's determination and the party proves that factors or circumstances beyond the party's reasonable control prevented the party from offering the additional evidence into the hearing record. Claimant provided information as to the nature of the work separation, however that information is not relevant and material to the issues before the EAB, whether claimant had good cause for filing a late request for hearing on decisions # 172027 and # 194329. EAB

therefore only consider claimant's written argument to the extent it was relevant and based on the hearing record when reaching this decision.

EAB reviewed the two hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 19-UI-135111 and 19-UI-135114 are affirmed.
