

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0815

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On July 2, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a \$1,952 overpayment, \$390.40 monetary penalty, and 26 penalty weeks (decision # 195531). Claimant filed a timely request for hearing. On August 1, 2018, ALJ Seideman conducted a hearing, and on August 2, 2018 issued Order No. 18-UI-114222, affirming the Department's decision. On August 22, 2018, Order No. 18-UI-114222 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). Almost a year later, on August 12, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On August 12, 2019, the appellant filed an application for review of Order No. 18-UI-114222 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than August 22, 2018. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although the appellant included a written statement with the application for review in this case, the statement did not include any explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed August 12, 2019 is dismissed. Order No. 18-UI-114222 remains undisturbed.
