EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0826

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On June 27, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from April 21, 2019 through May 11, 2019 because she did not perform any work seeking activities, and was ineligible for benefits for that period of time (decision # 83323). Claimant filed a timely request for hearing. On August 2, 2019, ALJ Griffin conducted a hearing, and on August 6, 2019 issued Order No. 19-UI-134534, reversing decision # 83323 and concluding that claimant is eligible for benefits from April 21, 2019 through May 11, 2019 based upon her work seeking activities. On August 26, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review should be dismissed.

On August 26, 2019, the Employment Appeals Board (EAB) received from claimant an application for review of an order that *allowed* the appellant benefits. In other words, the outcome of Order No. 19-UI-134534 was that claimant won that particular case. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling the appellant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the application for review before us presents no justiciable controversy, the application for review of Order No. 19-UI-134534 is dismissed. Order No. 19-UI-134534, which allowed benefits for the weeks of April 21, 2019 through May 11, 2019, remains undisturbed.

Please note, the Department can allow and deny weekly benefits for different reasons. While this decision upholds allowing benefits to claimant on the basis of her work seeking activities from April 21, 2019 through May 11, 2019, EAB Decision 2019-EAB-0827, also issued this day, denied benefits to claimant for the week of April 21, 2019 through April 27, 2019 on the basis of her availability for work. Therefore, benefits would only be payable to claimant for the weeks covered by this allowing decision if claimant is otherwise eligible and qualified to receive them.

Please also note that claimant has filed an application for review of Order No. 19-UI-134533, the order that concluded claimant was not available for work from April 21, 2019 to April 27, 2019 and May 5, 2019 to May 11, 2019, but was available for work from April 28, 2019 to May 4, 2019. That application for review will be addressed in separate EAB decision, but mailed on the same date and in the same envelope as this decision.

Claimant's applications for review of Order No. 19-UI-134534 and 19-UI-134533 also referenced a "3rd denial pending with OED under the decision # 80220" that was "related to late filing." That case is *not* before EAB for decision at this time for procedural reasons. EAB referred claimant's application for review to the Oregon Employment Department for review, and, potentially, referral to the Office of Administrative Hearings (OAH) for proceedings on claimant's request for hearing and, potentially, the late filing issue. If claimant has any questions about decision # 80220, or the status of the 3rd denial, claimant must direct those questions to the Department, or, if the case has been referred as a request for hearing, direct them to OAH.

DECISION: The application for review filed August 26, 2019 is dismissed. Order No. 19-UI-134534 remains undisturbed.
