EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0855

Reversed

Late Request for Hearing Allowed – Merits Hearing Required

PROCEDURAL HISTORY: On July 16, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not qualify for benefits for the period of June 16, 2019 through September 7, 2019 (decision # 141302). On August 5, 2019, decision # 141302 became final without claimant having filed a request for hearing. On August 9, 2019, claimant filed a late request for hearing. On August 14, 2019, ALJ Kangas issued Order No. 19-UI-135020, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew her request by filing a response to an appellant questionnaire by August 28, 2019. On August 30, 2019, claimant filed a timely application for review of Order No. 19-UI-135020 with the Employment Appeals Board (EAB) and a late response to the appellant questionnaire. On September 5, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 19-UI-135020 would remained in effect. This matter is before EAB based upon claimant's timely application for review of Order No. 19-UI-

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019), including claimant's response to the appellant questionnaire, and an envelope from the Department addressed to claimant, both of which are relevant to whether claimant's late request for hearing on decision # 141302 should be allowed. Claimant's response to the appellant questionnaire has been marked as EAB Exhibit 1, and the Department's envelope has been marked as EAB Exhibit 2. Copies of EAB Exhibits 1 and 2 have been provided to the parties with this decision. Any party that objects to the admission of EAB Exhibit 1 and/or 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) On July 23, 2019, the U.S. Postal Service returned the envelope containing decision # 141302 to the Department, even though the decision was addressed to claimant's correct

address. EAB Exhibits 1, 2. Claimant did not receive decision #141302 until August 24, 2019. EAB Exhibit 1.

(2) Sometime prior to August 9, 2019 claimant called the Department and was informed that her claim for benefits had been denied. EAB Exhibit 1. This prompted claimant to file a request for hearing on August 9, 2019. *Id*.

CONCLUSIONS AND REASONS: Claimant's late request for hearing on decision # 141302 is allowed. Claimant is entitled to a hearing on that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Here, claimant filed her request for hearing on decision # 141302 late because she was not aware of the existence of the decision until she called the Department to inquire about her claim for benefits and was told that her claim had been denied. Claimant did not personally receive decision # 141302 until August 24, 2019, after the filing deadline, because the U.S. Postal Service returned the decision to the Department as undeliverable although the envelope was correctly addressed. *See* EAB Exhibits 1, 2. Having the decision returned to the Department by the U.S. Postal Service was not within claimant's reasonable control. We infer from claimant's response to the appellant questionnaire that she likely filed her request for hearing within seven days after speaking with the Department and learning of the existence of decision # 141302 and therefore within a reasonable time. *See* EAB Exhibit 1. Claimant's late request for hearing on decision # 141302 is allowed. Claimant is entitled to a hearing on that decision. Claimant therefore established good cause to extend the filing deadline to August 9, 2019.

DECISION: Order No. 19-UI-135020 is set aside, as outlined above.
