

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0856

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On March 28, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from February 24, 2019, through March 2, 2019 (decision # 114711). Claimant filed a timely request for hearing. On April 18, 2019, ALJ Shoemake conducted a hearing, and on April 26, 2019 issued Order No. 19-UI-128871, concluding claimant did not actively seek work from February 24, 2019, through March 2, 2019. On May 16, 2019, Order No. 19-UI-128871 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 5, 2019, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed.

On September 5, 2019, the appellant filed an application for review of Order No. 19-UI-128871 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than May 16, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include “a written statement describing the circumstances that prevented a timely filing.” OAR 471-041-0070(3). Although the appellant included a written statement with the application for review in this case, the written statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed September 5, 2019 is dismissed. Order No. 19-UI-128871 remains undisturbed.
