

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0862

Affirmed
Late Request to Reopen Denied

PROCEDURAL HISTORY: On April 3, 2019, the Oregon Employment Department (the Department) served notices of two administrative decisions, one concluding that claimant quit working for the employer without good cause and was disqualified from benefits effective July 29, 2019 (decision # 154853), and the other assessing a \$1,208.00 overpayment, \$181.20 monetary penalty, and 8 penalty weeks (decision # 194621). Claimant filed a timely request for hearing on both decisions. On April 30, 2019, the Office of Administrative Hearings (OAH) mailed two notices of hearings both scheduled for May 14, 2019, one at 9:30 a.m. and the other at 10:45 a.m., at which times claimant failed to appear. On May 14, 2019, ALJ Snyder issued Order No. 19-UI-129901, dismissing claimant's request for hearing for failure to appear on decision # 154853 and No. 19-UI-129900, dismissing claimant's request for hearing for failure to appear on decision # 194621. On June 3, 2019, Orders No. 19-UI-129901 and 19-UI-129900 became final without claimant having filed a timely request to reopen the hearings. On August 22, 2019, claimant filed a late request to reopen both hearings. On August 27, 2019, ALJ Kangas reviewed claimant's request to reopen the two hearings, and issued Orders No. 19-UI-135663 and 19-UI-135665, denying claimant's request to reopen both hearings.

On September 5, 2019, claimant filed an application for review with the Employment Appeals Board of Orders No. 19-UI-135665 and 19-UI-135663. Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. Orders 19-UI-135665 and 19-UI-135663. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0862 and 2019-EAB-0863).

EAB reviewed the entirety of both hearing records, and claimant's argument to the extent it was based upon the records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 19-UI-135665 and No. 19-UI-135663 are affirmed.
