

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0864

Affirmed
No Disqualification

PROCEDURAL HISTORY: On August 1, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving unemployment insurance benefits (decision # 100939). The employer filed a timely request for hearing. On September 3, 2019, ALJ M. Davis conducted a hearing, and on September 4, 2019 issued Order No. 19-UI-136029, affirming the Department's decision. On September 10, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB did not consider the employer's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

Even if we had considered the argument, the outcome of this case would remain the same. Although the employer correctly identified that claimant's conduct violated ORS 471.410(2), that statute doesn't require that claimant have acted with any particular knowledge or mental state in order to have violated the law. In contrast, ORS 657.176 requires that claimant have acted with "misconduct" in order to be subject to disqualification, and "misconduct" is defined as "willful" or "wantonly negligent" actions or inactions, which means that the individual must have either acted with intent or been "conscious" of the conduct and "knew or should have known" that the conduct would probably violate the employer's expectations. *See* OAR 471-030-0038(1) and (3) (December 23, 2018).

In this case, claimant actually complied with the employer's expectations by checking the underage customers' ID before serving the customers, and only violated the employer's expectations – and the law – inadvertently because he misread the ID. Claimant's conduct does not fit the definition of willful or wantonly negligent, and his discharge for engaging in that conduct therefore was not misconduct, even though it violated ORS 471.410(2).

The employer also suggested that even though claimant acted inadvertently, he should still be disqualified from benefits under OAR 471-030-0038(1)(d)(D), which states, "Acts that violate the law . .

. exceed mere poor judgment and do not fall within the exculpatory provisions of OAR 471-030-0038(3).” That portion of the rule only applies, however, if the final incident – here, claimant serving an underage minor – was willful or wantonly negligent. Because claimant did not act willfully or with wanton negligence when he served an underage minor, his conduct was not misconduct, even though the conduct violated ORS 671.410(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-136029 is affirmed.
