EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0873

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was ineligible for benefits from May 5 through 18, 2019 (decision # 104900). Claimant filed a timely request for hearing. On June 26, 2019, ALJ S. Lee conducted a hearing, and on July 3, 2019 issued Order No. 19-UI-132714, modifying decision # 104900 by concluding that claimant was eligible for benefits from May 5 through 11, 2019, but not from May 12 through 18, 2019. On July 23, 2019, Order No. 19-UI-132714 became final without claimant having filed an application for review with EAB. On August 26, 2019, claimant filed a late application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 19-UI-132714 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

With his application for review, claimant submitted a copy of Order No. 19-UI-132714 with a stamp indicating that it had been "REMAILED FOR YOUR INFORMATION ONLY[.] ORIGINAL DATE OF MAILING CONSTITUTES DATE OF SERVICE." Claimant stated in his application for review that, "I would like to appeal this decision. . . . I did check with the people here at the house and since we all get the mail, no one remembers getting anything from you? However, I have received the last two mailings."

We infer from claimant's application for review that he may not have received notice of Order No. 19-UI-132714 until it was re-mailed to him. However, claimant did not state when he received the remailed notice. Absent that information, EAB cannot find that claimant's alleged failure to receive the first notice prevented him from filing a timely application for review, much less that he filed his application for review within a reasonable time, seven days after receiving the re-mailed notice. Claimant therefore failed to establish good cause to extend the July 23rd filing deadline to August 26th.

DECISION: The application for review filed August 26, 2019 is dismissed. Order No. 19-UI-132714 remains undisturbed.
