

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0912**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On June 26, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct (decision # 153416). Claimant filed a timely request for hearing. On August 9, 2019, ALJ Shoemake conducted a hearing, and on August 15, 2019, issued Order No. 19-UI-135119, affirming the Department's decision. On September 4, 2019, Order No. 19-UI-135119 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 20, 2019, claimant filed a late application for review with EAB.

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On September 20, 2019, the appellant filed an application for review of Order No. 19-UI-135119 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than September 4, 2019. The deadline for filing a late application for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). The appellant provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

**DECISION:** The application for review filed September 20, 2019 is dismissed. Order No. 19-UI-135119 remains undisturbed.
