

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0916

Affirmed
Late Requests for Hearing Dismissed

PROCEDURAL HISTORY: On July 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant did not actively seek work from June 9 through 22, 2019 (decision # 113842). On July 24, 2019, the Department served notice of another administrative decision assessing a \$321.00 overpayment that claimant was liable to repay (decision # 105803). On July 29, 2019, decision # 113842 became final without claimant having filed a timely request for hearing. On August 13, 2019, decision # 105803 became final without claimant having filed a timely request for hearing. On August 21, 2019, claimant filed late requests for hearing on both decisions. On August 26, 2019, ALJ Kangas issued Order No. 19-UI-135551, dismissing claimant's late request for hearing on decision # 113842, and Order No. 19-UI-135550, dismissing claimant's late request for hearing on decision # 105803, both subject to her right to renew the requests by responding to an appellant questionnaire within 14 days. Claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response and on September 18, 2019 issued Order No. 19-UI-136639 re-dismissing claimant's late request for hearing on decision # 113842 and Order No. 19-UI-136637 re-dismissing claimant's late request for hearing on decision # 105803. This matter is before the Employment Appeals Board (EAB) on claimant's timely applications for review of Orders No. 19-UI-136639 and No. 19-UI-136637.

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-136637 and 19-UI-136639. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0915 and 2019-EAB-0916).

Claimant submitted written argument with her application for review. EAB considered claimant's written argument to the extent that it was relevant and based on the hearing record.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 19-UI-136639 and No. 19-UI-136637 are affirmed.
