

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0917

Order No. 19-UI-136475 Affirmed – No Disqualification
Order No. 19-UI-136476 Affirmed – No Overpayment or Penalties

PROCEDURAL HISTORY: On August 14, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause (decision # 143145). On August 14, 2019, the Department served notice of another administrative decision, based on decision # 143145, assessing a \$5,488 overpayment, a \$823.20 monetary penalty, and a 36-week penalty disqualification from benefits (decision # 194204). On August 17, 2019, claimant filed a timely request for hearing on decision # 143145. On August 19, 2019, claimant filed a timely request for hearing on decision # 194204.

On September 13, 2019, ALJ M. Davis conducted a combined hearing regarding decisions # 143145 and 194204. On September 13, 2019, ALJ M. Davis issued Order No. 19-UI-136475, setting aside decision # 143145 and concluding the employer discharged claimant, but not for misconduct,¹ and Order No. 19-UI-136476, setting aside decision # 194204 and concluding the Department did not overpay claimant benefits and claimant was not subject to a monetary penalty or penalty weeks. On September 25, 2019, the employer filed applications for review of both hearing orders with the Employment Appeals Board (EAB). On October 10, 2019, the employer submitted written argument in support of its applications for review.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 19-UI-136475 and 19-UI-136476. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0918 and 2019-EAB-0917, respectively).

¹ ORS 657.176(8) provides that when an individual has notified an employer that he will quit work on a specific date, and the employer discharged him, not for misconduct, no more than fifteen days prior to that date, and the quit would have been without good cause, the work separation is adjudicated as if the discharge had not occurred and the planned quit had occurred, and the individual is disqualified from receiving benefits, except that he is eligible for benefits for the period including the week in which the actual discharge occurred through the week prior to the week of the planned quit date. That statute does not apply here because even if claimant's planned quit would have been without good cause, the employer discharged claimant on April 14, 2019, which was more than fifteen days prior to claimant's planned quit date of May 10, 2019.

EAB reviewed the employer's written argument and the entire hearing record in both cases. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 19-UI-136475 and 19-UI-136476 are affirmed.
