

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0932

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On December 20, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work and denying benefits for the period of November 19, 2017 through December 2, 2017, (decision # 145814). On December 21, 2017, the Department served notice of a second administrative decision, based in part on decision # 145814, assessing a \$1,180.00 overpayment, \$177.00 monetary penalty, and 8 penalty weeks (decision # 194050). On January 9, 2018, decision # 145814 became final without claimant having filed a timely request for hearing. On January 10, 2018, decision # 194050 became final without claimant having filed a timely request for hearing.

On February 1, 2018, claimant filed a late request for hearing on both decisions. On February 8, 2018, ALJ Kangas issued Orders No. 18-UI-102821 and 18-UI-012823, dismissing claimant's late request for hearing on decisions # 145814 and 194050 subject to his right to renew the request by responding to an appellant questionnaire by February 22, 2018. On February 15, 2018, claimant responded to the appellant questionnaire. On February 21, 2018, the Office of Administrative Hearings (OAH) mailed two letters stating that Orders No. 18-UI-102821 and 18-UI-012823 were canceled. On February 27, 2018, OAH mailed notices scheduling two hearings for March 28, 2018, one at 9:30 a.m., and the other at 10:45 a.m., at which times claimant failed to appear. On March 29, 2018, ALJ Wyatt issued Order No. 18-UI-106191, dismissing claimant's request for hearing on decision # 145814, and Order No. 18-UI-106192 dismissing claimant's request for hearing on decision # 194050, for failure to appear. On April 18, 2018, Orders No. 18-UI-106191 and No. 18-UI-106192 became final without claimant having filed a timely request to re-open the March 28, 2018 hearings. On August 30, 2019, claimant filed a late request to reopen the hearings. ALJ Kangas considered claimant's request, and on September 9, 2019 issued Orders No. 19-UI-136284 and 19-UI-136290 dismissing the request.

On September 30, 2019, claimant filed a timely application for review of Orders No. 19-UI-136284 and No. 19-UI-136290 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019); EAB consolidated its review of Orders No. Orders No. 19-UI-136284 and No. 19-UI-136290.

For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0932 and 2019-EAB-0933).

Claimant submitted written argument. However, claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record in their request to reopen the March 23, 2018 hearings. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record in both cases. On de novo review and pursuant to ORS 657.275(2), the Orders under review are **adopted**.

DECISION: Orders No. 19-UI-136284 and No. 19-UI-136290 are affirmed.
