

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0935

Affirmed
Disqualification

PROCEDURAL HISTORY: On August 22, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause (decision # 111313), and an administrative decision concluding that claimant was not available for work from July 14 through August 17, 2019 (decision # 113950). Claimant filed timely requests for hearing on both decisions. On September 18, 2019, ALJ Frank conducted a consolidated hearing, and on September 27, 2019 issued Order No. 19-UI-137221 affirming decision # 111313, and Order No. 19-UI-137230 modifying decision # 113950 by concluding that claimant was not available for work from July 14 through September 14, 2019. On October 1, 2019, claimant filed timely applications for review of Orders No. 19-UI-137221 and 19-UI-137230 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-137221 and 19-UI-137230. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0936 and 2019-EAB-0935).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 19-UI-137221 and 19-UI-137230 are affirmed.
