EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0939

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 23, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant guit working for the employer without good cause and was denied benefits beginning August 4, 2018 (decision # 161151). On May 13, 2019, decision # 161151 became final without claimant having filed a request for hearing. On August 26, 2019, claimant filed a late request for hearing. On September 4, 2019, ALJ Kangas issued Order No. 19-UI-136085, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew her request by filing a response to an appellant questionnaire by September 18, 2019. On September 24, 2019, Order No. 19-UI-136085 became final without claimant having filed a response to the appellant questionnaire or an application for review of Order No. 19-UI-136085 with the Employment Appeals Board (EAB). On September 27, 2019, claimant filed a late response to the appellant questionnaire with the Office of Administrative Hearings (OAH), which also was construed as a late application for review of Order No. 19-UI-136085 with EAB. On October 1, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 19-UI-136085 remained in effect. This decision is being issued based on claimant's late application for review of Order No. 19-UI-136085 with EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 19-UI-136085 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

In this case, the application for review of Order No. 9-UI-136085 was due by September 24, 2019. The appellant did not file her application for review until September 27, 2019. Although the appellant included a written statement with her application for review, that statement provided no explanation as to why the application was filed after the filing deadline expired. Accordingly, the application for review is dismissed.

DECISION: The application for review filed September 27, 2019 is dismissed. Order No. 19-UI-136085 remains undisturbed.
