

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0941**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On September 6, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying him from benefits effective July 14, 2019, and concluding that claimant's wage credits should not be canceled (decision # 84946). Claimant filed a timely request for hearing. On September 26, 2019, ALJ Janzen conducted a hearing, and on September 27, 2019 issued Order No. 19-UI-137170, affirming the Department's decision.<sup>1</sup> On October 1, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-137170 is affirmed.

<sup>1</sup> The ALJ marked a video the employer submitted as Exhibit 1, but did not admit Exhibit 1 into evidence because the employer did not provide a copy of the video to claimant. OAH did not provide EAB with a copy of Exhibit 1 when OAH sent the record to EAB. Ordinarily OAH's failure to provide EAB with a complete record requires remand; in this case it does not because the video was not admitted into evidence and no party alleged the ALJ's exclusion of the video from evidence was error. EAB reached this decision based upon the information admitted into evidence at the hearing, excluding Exhibit 1.
