EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0946

Affirmed Request to Reopen Denied

PROCEDURAL HISTORY: On June 10, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct (decision # 134746). The employer filed a timely request for hearing. On June 26, 2019, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 11, 2019 at 4:30 p.m. On July 11, 2019, ALJ Frank conducted a hearing, at which claimant failed to appear, and on July 19, 2019 issued Order No. 19-UI-133690, concluding that claimant voluntarily left work without good cause and he was disqualified from receiving benefits effective May 26, 2019. On August 7, 2019, claimant filed a timely request to reopen the July 11th hearing. On August 20, 2019, OAH mailed notice of a hearing on September 3, 2019 at 9:30 a.m. On August 29, 2019, OAH mailed notice of a hearing, at which claimant and the employer appeared, and on September 20, 2019 issued Order No. 19-UI-136842, denying claimant's request to reopen. On September 25, 2019, claimant filed a timely application for review of Order No. 19-UI-136842 with the Employment Appeals Board (EAB).

EAB did not consider claimant's written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). Additionally, the bulk of claimant's argument was not pertinent to the reopen issue, which is the only issue over which EAB has jurisdiction.

FINDINGS OF FACT: Claimant personally received notice of the July 11th hearing on an unknown date after the notice was mailed to his address. He did not always personally collect his mail, and did not always see it immediately. Claimant looked at the notice but the importance of it did not register. He

thought the notice might be related to a different matter and did not understand that the notice was informing him that a hearing was going to be held about his unemployment insurance case.

CONCLUSIONS AND REASONS: Claimant's request to reopen should be denied.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012).

Claimant filed a timely request to reopen but did not establish good cause to reopen the July 11th hearing. Many factors understandably affected the way claimant attended to the notice of hearing after it was received at his address, including that he did not always collect the mail, did not always see his mail immediately, and had other matters going on in which he received official-looking mail. However, OAR 471-040-0040(2)(b)(B) specifically says that "[g]ood cause does not include Not understanding the implications of a decision or notice when it is received." In this case, the preponderance of the evidence suggests that claimant did in fact receive the notice of hearing. There is no evidence that he experienced interruptions in his mail delivery service that suggest the notice was unduly delayed rather than delivered to his address within a few days after being mailed to him. The reason claimant did not attend to it because the nature of the document and its importance did not register with him. Because claimant's failure to appear at the July 11th hearing primarily occurred because he did not understand the implications of the notice scheduling that hearing when he received it, he has not shown good cause to reopen the hearing, and his request to reopen must be denied.

DECISION: Order No. 19-UI-136842 is affirmed.
