

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0947

Application for Review Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On August 16, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 155543). Claimant filed a timely request for hearing. On September 19, 2019, ALJ Janzen conducted a hearing, and on September 20, 2019 issued Order No. 19-UI-136894, concluding claimant voluntarily left work with good cause. On October 3, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: The appellant's application for review should be dismissed.

On October 3, 2019, the Employment Appeals Board (EAB) received from the appellant what appears to be an application for review of an order that *allowed* the appellant benefits. The appellant did not assign error to any portion of that order, and did not request reversal of any portion of the order. Instead, claimant asked EAB to determine whether she can now claim benefits for weeks that she did not claimant before Order No. 19-UI-136894 concluded that she was not disqualified from receiving benefits based on her work separation from the employer. However, neither decision # 155543 nor Order No. 19-UI-136894 addressed that issue, which therefore cannot be reviewed by EAB in this case. Accordingly, there is no justiciable controversy before EAB based upon the appellant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before us presents no justiciable controversy, the application for review of Order No. 19-UI-136894 is dismissed. Order No. 19-UI-136894 remains undisturbed.

DECISION: The application for review filed October 3, 2019 is dismissed. Order No. 19-UI-136894 remains undisturbed.
