

**EMPLOYMENT APPEALS BOARD DECISION**  
**2019-EAB-0952**

*Applications for Review Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On July 23, 2019, the Oregon Employment Department (the Department) served notices of two administrative decisions, one concluding that claimant was denied benefits for the weeks from December 28, 2018 through February 23, 2019 (decision # 70900), and the other concluding that claimant was denied benefits for the weeks from March 3 through 23, 2019 (decision # 72614), because his claims for those weeks were late. Claimant filed a timely request for hearing on both decisions. On September 10, 2019, ALJ Janzen conducted a hearing on both decisions and issued Order No. 19-UI-136339 affirming decision # 70900, and Order No. 19-UI-136338 affirming decision # 72614. On September 30, 2019, Orders No. 19-UI-136339 and 19-UI-136338 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On October 3, 2019, claimant filed late applications for review of Orders No. 19-UI-136339 and 19-UI-136338 with EAB.

Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-136339 and 19-UI-136338. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2019-EAB-0953 and 2019-EAB-0952).

**CONCLUSIONS AND REASONS:** Claimant's late applications for review of Orders No. 19-UI-136339 and 19-UI-136338 are dismissed.

On October 3, 2019, 2019, the appellant filed applications for review of Orders No. 19-UI-136339 and 19-UI-136338 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than September 30, 2019. The deadline for filing late applications for review may be extended under certain circumstances. OAR 471-041-0070. In order to be considered for such an extension, however, an individual must include "a written statement describing the circumstances that prevented a timely filing." OAR 471-041-0070(3). Although claimant included a written statement with his applications for review, it provided no explanation as to why the applications were filed after the filing deadline expired. Accordingly, the application for reviews are dismissed.

**DECISION:** The applications for review filed October 3, 2019 are dismissed. Orders No. 19-UI-136339 and 19-UI-136338 remain undisturbed.
