# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0955

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 1, 2019, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision concluding that claimant was overpaid \$604 in benefits that he must repay the Department (decision #140025). On July 22, 2019, decision #140025 became final without claimant having filed a request for hearing. On September 3, 2019, claimant filed a late request for hearing. On September 12, 2019, ALJ Kangas issued Order No. 19-UI-136365, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 26, 2019. On September 30, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-136365 with the Employment Appeals Board (EAB). On October 3, 2019, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was late, it would not be considered and Order No. 19-UI-136365 remained in effect. This decision is being issued based on claimant's timely application for review of Order No. 19-UI-136365 with EAB.

EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing on decision # 140025 is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

In his request for hearing and response to the appellant questionnaire, claimant indicated that he filed his request for hearing on decision # 140025 late because he was working out-of-town during July 2019, and did not personally receive the decision until he returned. *See* Exhibit 2 at 2, EAB Exhibit 1 at 2. However, claimant also indicated in his request for hearing that he filed the request about one month after he returned. Exhibit 2 at 2. Thus, even if claimant had good cause for filing his request for hearing late, he failed to show that he filed it within a reasonable time, seven days, after the factors that prevented a timely filing ceased to exist.

Claimant's late request for hearing on decision #140025 therefore is dismissed.

**DECISION:** Order No. 19-UI-136365 is affirmed.
