

EMPLOYMENT APPEALS BOARD DECISION
2019-EAB-0963

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On March 28, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the week of March 3 through 9, 2019, and was ineligible for benefits that week (decision # 120404). On April 3, 2019, the Department served notice of an administrative decision concluding that claimant did not actively seek work during the week of February 24 through March 2, 2019, and was ineligible for benefits that week (decision # 100850). On April 17, 2019, decision # 120404 became final without claimant having filed a request for hearing. On April 23, 2019, decision # 100850 became final without claimant having requested a hearing.

On July 24, 2019, the Department served notice of an administrative decision, based on decision # 100850, concluding that claimant was overpaid \$417 in benefits for the week of February 24th through March 2nd that he must repay the Department (decision # 122131). On July 25, 2019, the Department served notice of a decision, based on decision # 120404, concluding that claimant was overpaid \$417 in benefits for the week of March 3rd through March 9th that he must repay the Department (decision # 93729). On July 30, 2019, claimant filed a late request for hearing on decisions # 120404 and 100850, and a timely request for hearing on decisions # 122131 and 93729. On August 5, 2019, the Office of Administrative Hearings (OAH) served notice of a consolidated hearing scheduled for August 20, 2019. On August 20th, claimant failed to appear at the hearing, and ALJ Frank issued Orders No. 19-UI-135277, 19-UI-135284, 19-UI-135287 and 19-UI-135278, dismissing claimant's requests for hearing for failure to appear.

On September 7, 2019, claimant filed a timely request to reopen the August 20th hearing. ALJ Kangas considered claimant's request, and on September 19, 2019 issued Orders No. 19-UI-136733, 19-UI-136742, 19-UI-136731 and 19-UI-136732, denying the request. On October 4, 2019, claimant filed timely applications for review of Orders No. 19-UI-136733, 19-UI-136742, 19-UI-136731 and 19-UI-136732 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (May 13, 2019), EAB consolidated its review of Orders No. 19-UI-136733, 19-UI-136742, 19-UI-136731 and 19-UI-136732. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2019-EAB-0965, 2019-EAB-0966, 2019-EAB-0963 and 2019-EAB-0964).

EAB reviewed all four hearing records and claimant's written argument. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 19-UI-136733, 19-UI-136742, 19-UI-136731 and 19-UI-136732 are affirmed.
