EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0974

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 19, 2019, the Oregon Employment Department (the Department) served, by mail, notice of an administrative decision denying claimant benefits for the week of June 30 through July 6, 2019 for failing to comply with the Department's request to provide hours worked and earnings for that week, or the last day worked prior to that week, by July 16, 2019 (decision # 145714). On August 8, 2019, decision # 145714 became final without claimant having filed a request for hearing. On August 10, 2019, claimant filed a late request for hearing. On September 17, 2019, ALJ Kangas issued Order No. 19-UI-136583, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by October 1, 2019. On October 2, 2019, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 19-UI-136583 with the Employment Appeals Board (EAB). On October 8, 2019, ALJ Kangas issued a letter stating that because claimant's response was late, it would not be considered, and Order No. 19-UI-136583 remained in effect.

This decision is being issued based on claimant's timely application for review of Order No. 19-UI-136583 with EAB. EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1 and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 19-UI-136583 is reversed and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 145714 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The record shows that decision # 145714 likely was delivered to claimant's residence while she was out-of-town, travelling to determine whether to accept a job offer to work in a remote area, and that she may not have returned to her residence in time to file a timely request for hearing. EAB Exhibit 1. The record therefore suggests that claimant's failure to a file a timely request for hearing may have been due to factors beyond her reasonable control an excusable mistake, or a combination thereof. However, further inquiry is needed to make that determination, including, but not limited to, when claimant last checked her mail before leaving town, when she left town, where she travelled to, how long she expected to be away from her residence, when she returned, and when she checked her mail after returning.

Order No. 19-UI-136583 therefore is reversed and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 145714 should be allowed and, if so, the merits of that decision.

DECISION: Order No. 19-UI-136583 is set aside, and this matter remanded for further proceedings consistent with this order.
