# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0975

Affirmed
No Disqualification

**PROCEDURAL HISTORY:** On August 26, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 132304). Claimant filed a timely request for hearing. On September 20, 2019, ALJ Scott conducted a hearing, and on September 23, 2019, issued Order No. 19-UI-136949, concluding claimant voluntarily left work with good cause. On October 14, 2019, the employer filed an application for review with the Employment Appeals Board (EAB).

EMPLOYER'S WRITTEN ARGUMENT: Claimant quit work to avoid a potential discharge for attendance violations that were due to her medical conditions. Because claimant would have been eligible for rehire if she quit, and not eligible for rehire if the employer discharged her, claimant elected to quit rather than be discharged. The employer asserted in its written argument that, at the time claimant quit, the employer was not going to discharge her. The employer asserted that claimant was going to receive a "level 5" warning at the meeting it had requested with claimant in July 2019, which would not have resulted in immediate termination, and would have given claimant an opportunity to correct her behavior and request accommodations from the employer to address her disabilities. The employer is essentially arguing that that claimant had the reasonable alternative of continuing to work, improving her attendance, and seeking accommodations from the employer to address her medical conditions. However, although the employer asserts in its argument that it was not going to discharge claimant, the employer did not provide that information at the hearing, and the record does not otherwise support that assertion. To the contrary, claimant's supervisor testified that, "level 5 is termination." Transcript at 21. The supervisor also testified that, "there is no preconceived notion about the outcome" of the type of meeting the employer had requested with claimant. Transcript at 18. When asked at the hearing if it was likely that claimant was going to be discharged at the meeting, the supervisor did not deny the possibility of discharge, and stated that he could not "go into [the meeting] with a preconceived notion." Transcript at 19-20. The employer did not tell claimant that she would receive only a warning at the meeting and based on the supervisor's testimony, discharge was a possible outcome of the meeting. Claimant reasonably believed that discharge was imminent based on her prior warnings, her attendance violations since that warning, her ineligibility for family medical leave, and the request from human

resources that she arrange a meeting with them and her supervisor. Moreover, because claimant wanted to preserve the possibility of returning to work with the employer and a discharge appeared imminent, seeking accommodation was not a reasonable alternative for claimant once she was already at "level 5." Claimant knew from her supervisor that she would not be eligible for rehire if the employer discharged her. For these reasons, and the reasons explained in the order under review, the record shows that claimant quit work with good cause.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 19-UI-136949 is affirmed.
