# EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0980

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On May 8, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct connected with work (decision #150750). Claimant filed a timely request for hearing. On May 29, 2019, the Office of Administrative Hearing (OAH) served notice of a hearing scheduled for June 11, 2019. On June 11, 2019, ALJ Murdock convened a hearing at which claimant failed to appear, and on June 12, 2019 issued Order No. 19-UI-131520 dismissing claimant's request for hearing for failure to appear. On July 2, 2019, Order No. 19-UI-131520 became final without claimant having filed a request to reopen the June 11<sup>th</sup> hearing. On July 3, 2019, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on July 16, 2019 issued Order No.19-UI-133405, dismissing the request. On August 5, 2019, Order No. 19-UI-133405 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 9, 2019, claimant filed a late application for review with the EAB.

**CONCLUSIONS AND REASONS:** The application for review is dismissed as untimely without a showing of good cause to extend the filing deadline.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

In this case, the application for review of Order No. 19-UI-133405 was due by August 5, 2019. The appellant did not file their application for review until October 9, 2019. Claimant stated in their application for review "I later rec[e]ived the paperwork [] of the hearing verdict and information on appeals. With the lack of funds and need for work I concentrated on finding work and talking to recruiters when I was able." EAB infers from claimant's statement that they did not file a timely

application for review because they were concentrated on finding employment. However, claimant failed to show that it was beyond their reasonable control to file a timely application for review while looking for employment. Nor did claimant show that they filed their application for review within a reasonable time, seven days, after the factors or circumstances that allegedly prevented a timely filing ceased to exist. Claimant therefore failed to establish good cause to extend the August 5<sup>th</sup> filing deadline to October 9<sup>th</sup>. Accordingly, the late application for review is dismissed.

**DECISION:** The application for review filed October 9, 2019 is dismissed. Order No. 19-UI-133405 remains undisturbed.
