EMPLOYMENT APPEALS BOARD DECISION 2019-EAB-0991

Affirmed Disqualification

PROCEDURAL HISTORY: On September 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause (decision # 113141). Claimant filed a timely request for hearing. On October 1, 2019, ALJ Murray-Roberts conducted a hearing, and on October 9, 2019, issued Order No. 19-UI-137803, affirming the Department's decision. On October 15, 2019, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB did not consider the written argument claimant put on the application for review form she submitted to EAB when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

Claimant also submitted written argument to EAB on October 23, 2019, a copy of which she provided to the employer. Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision, and the portions of claimant's written argument that are based on that information.

Claimant argued in her written argument that she was not eligible for a leave of absence. To the extent, the order under review stated that claimant had the reasonable alternative of asking for a leave of absence, the record does not show that claimant had leave available to her at the time she quit. However, as the order stated, claimant had the reasonable alternative of contacting human resources about her dissatisfaction with her working environment. Claimant argued that speaking to human resources was not a reasonable alternative because she believed it would worsen her working conditions, because her working conditions did not improve when she spoke directly to the employees who had caused her anxiety symptoms. The record shows that claimant did not complain to human resources about the incidents that caused her anxiety, but does not support claimant's assumption that human resources

would not take action to correct other employees' behavior toward claimant if claimant complained. Moreover, the record does not show that the employees' conduct toward claimant was so egregious that claimant had to quit work immediately, before speaking with human resources. To the extent claimant left work due to her health, nor does the record show that claimant's symptoms were so severe that she had no reasonable alternative but to quit work immediately. Claimant's doctor did not recommend that claimant quit work immediately, but recommended she find less stressful work. Claimant followed her doctor's orders and sought other work. However, when claimant left work it was not because she had gotten another job, it was based on the mere possibility that another employer would offer her work once it checked claimant's references, and claimant passed background and education checks, and a drug screen. Exhibit 1. It is not good cause to leave work to accept an offer of other work unless the offer is definite. OAR 471-030-0038(5)(a) (December 23, 2018). The other employer had not yet offered claimant work, let alone made a definite offer of work. See Exhibit 1.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 19-UI-137803 is affirmed.
